**ZONING DOCKET 116-08** - Request by CITY COUNCIL MOTION M-08-642 for the establishment of an Interim Zoning District (IZD) to be named the "Central City Mixed Use Interim Zoning District," prohibiting the establishment of any uses other than those authorized as permitted, accessory or conditional in the C-1A General Commercial District, for the entirety of Squares 238, 239, 253, 254, 277 and 278, in the First Municipal District, generally bounded by South Rampart, Erato and Carondelet Streets and the Pontchartrain Expressway. (ZBM C-14).

**ZONING DOCKET 117-08** - Request by LILLY F. PATTERSON for a Zoning Change from an RM-2 Multiple-Family Residential District to a B-1A Neighborhood Business District, within the ICUC Inner-City Urban Corridor District overlay, on Square 669, Lot 19, in the Sixth Municipal District, bounded by General Taylor, Willow and Milan Streets and South Claiborne Avenue. The municipal addresses are 2916 and 2918 GENERAL TAYLOR STREET. (ZBM B-14)

**ZONING DOCKET 118-08** - Request by ANTHONY J. CIACCIO for a Zoning Change from an RD-2 Two-Family Residential District to an RM-2A Multiple-Family Residential District, on Square 421, Lot M, in the Sixth Municipal District, bounded by Amelia, Peniston and Carondelet Streets and Saint Charles Avenue. **ZONING DOCKET 119-08** - Request by MELVET L. DANGERFIELD for a Zoning Change from an RD-2 Two-Family Residential District to a B-1A Neighborhood Business District, on Square D, Lot 31, in the Sixth Municipal District, bounded by Toledano, South Roman and South Galvez Streets and Louisiana Avenue Parkway. The municipal address is 3100 TOLEDANO STREET. (ZBM B-14)

**ZONING DOCKET 120-08** - Request by NOTEWORTHY PROPERTIES, L.L.C. for a Zoning Change from an RD-3 Two-Family Residential District to a B-1A Neighborhood Business District, on Square 1361, Lot 1, in the Third Municipal District, bounded by North Broad, Aubry, D'Abadie and Rousselin Streets. The municipal addresses are 1700 and 1702 NORTH BROAD STREET. (ZBM D-12)
