**ZONING DOCKET 27-09** - Request by J.C. GOOD NEWS, INC. for a Conditional Use to permit a non-accessory parking lot in an RD-3 Two-Family Residential District, on Square 1165, Lot O, in the Third Municipal District, bounded by North Tonti, North Miro and Painters Streets and Franklin Avenue. The municipal address is 2600 NORTH TONTI STREET. (ZBM D-13)

**ZONING DOCKET 28-09** - Request by PTC FAMILY INVESTMENTS, L.L.C. for a Zoning Change from an RD-3 Two-Family Residential District to a B-1A Neighborhood Business District, on Square 239, Lot B or 2, in the Sixth Municipal District, bounded by Magazine, Camp, Robert and Soniat Streets. The municipal addresses are 5025-5027 MAGAZINE STREET. (ZBM B-15)
