AN ORDINANCE to amend and reordain Chapter 78 of the Code of the City of New Orleans to add the Advisory Base Flood Elevations as published on April 12, 2006; and otherwise to provide with respect thereto.

SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY

ORDAINS that Section 78-38 of Chapter 78 of the Code of the City of New Orleans be and is hereby amended and reordained to read as follows:

Chapter 78. FLOODS

Sec. 78-38. Statement of Purpose.

* * *

(b) Official flood maps entitled Flood Insurance Rate Maps (FIRM) for Orleans Parish, Louisiana (Community Panel No. 225203 0001-0185), dated March 1, 1984, as amended, inclusive of FEMA Letters of Map Amendment dated May 9, 1984 and August 29, 1984, relative to Tall Timbers Extensions, Ponding Area 33, and inclusive of FEMA conditional Letter of Map Revision, dated July 11, 1986, relative to the South Shore Harbor Project, or the Advisory Base Flood Elevation of three feet above the highest curb height in front of the building site or the required flood elevation, as published on April 12, 2006, whichever is higher, are adopted by the

15 City and on file with the Clerk of Council. All properties located within the jurisdiction of the
16 Historic Landmarks Commission, Vieux Carré Commission, National Register District, or
17 property that is included in the definition of "historic structure" under the National Flood
18 Insurance Program, shall be exempt from the advisory Base Flood Elevations published on April
19 12, 2006.

1 **SECTION 2. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**
2 **ORDAINS** that the provisions of the Advisory Base Flood Elevations, as published on April 12,
3 2006, shall become effective on September 15, 2006.
